競爭事務委員會宣佈委任行政總裁

競爭事務委員會(競委會)今日(2014年7月21日)宣佈委任 Stanley Wong 博士出任行政總裁。 Stanley Wong 博士將於2014年9月3日履新。

Stanley Wong 博士擁有近 30 年與競爭法相關的經驗。他於 1984 年在加拿大展開其私人執業律師工作,就競爭法各範疇,包括卡特爾(cartels)、濫用市場權勢、合併及私人訴訟提供法律意見。 Stanley Wong 博士曾擔任加拿大最高法院、上訴法院及審判庭,以及加拿大競爭事務審裁處的訟務律師。

2006年,Stanley Wong 博士獲委任為愛爾蘭競爭事務局委員,他在任的五年內首先負責民事個案的執法工作,繼而專責合併的事務。其後 Stanley Wong 博士在加拿大自組律師事務所,為新加坡、馬來西亞、英國、歐盟委員會、哥倫比亞、南非和加拿大等世界各地的競爭事務機構、法庭和審裁處提供顧問服務。

Stanley Wong 博士現時掌舵歐盟委員會的多個項目,為中國競爭事務機構(商務部、國家發展和改革委員會、國家工商行政管理總局),以及印度競爭事務委員會,就提升能力方面提供技術支援。多年來,Stanley Wong 博士積極參與經濟合作與發展組織(OECD)及國際競爭規管網絡(ICN)的工作,亦曾擔任國際競爭規管網絡合併工作小組的聯席主席。

Biography of Dr. Stanley Wong



Dr. Stanley Wong, a Canadian lawyer, provides advice on competition law enforcement and competition policy exclusively to competition authorities and governments around the world. From 2006 to 2011, he served as a Member (commissioner) of the Competition Authority (Ireland). In this capacity, he was responsible for civil enforcement (2006-2009) and mergers (2009-2011). He represented the Authority in consultations by the European Commission on enforcement cases and policy initiatives under the European Competition Network. He frequently participated in the work of the Competition Committee of Organisation for Economic Co-operation and Development (OECD) and International Competition Network (ICN). He served as co-chair of the ICN Merger Working Group.

Since 2011 to present, he is advising or has advised competition authorities, courts and tribunals around the world including: Singapore, Malaysia, Philippines, United Kingdom, European Commission, Croatia, South Africa, Colombia and Canada. He has served as an advisor to the United Nations of Conference on Trade and Development (UNCTAD) Intergovernmental Group of Experts on Competition Law and Policy and the Organisation for Islamic Cooperation. He currently leads the European Commission projects to provide capacity-building technical assistance to the Chinese competition authorities (Ministry of Commerce - MOFCOM, National Development and Reform Commission - NDRC and State Administration for Industry and Commerce - SAIC) and to the Competition Commission of India. He serves as an ICN non-government advisor for the Canadian Competition Bureau and European Commission (DG COMP).

He was previously head of the competition law practice of the leading Canadian law firm, Davis LLP. He practiced principally through the firm's Vancouver and Toronto offices. From 1999 to 2004, he served as the founding managing partner of the Toronto office. In his private practice, he advised on all aspects of competition law regarding anti-competitive agreements (cartels), anti-competitive unilateral conduct, mergers and private actions. He also acted as counsel before the Supreme Court of Canada, appellate and trial courts and the Competition Tribunal. He is a past chair of the National Competition Law Section of the Canadian Bar

Association. He was recognised as a leading competition lawyer by independent guides such as Chambers Global, Global Competition Review and Lexpert/American Lawyer Guide to the Leading 500 Lawyers in Canada.

He is qualified as a barrister and solicitor in the Canadian provinces of Ontario and British Columbia and as a solicitor (non-practising) in England and Wales.

Before entering the practice of law, he was an associate professor of economics at Carleton University in Ottawa, Canada. He has two degrees in economics, B.A. (Simon Fraser) and Ph.D. (Cambridge) and a law degree, LL.B. (Toronto).
